


2012: ~ USD 37 billion

2008-2012: Revenue & Total Asset (USD billion)




Petrovietnam - Main business segments

2P Reserves: approximately 1.4 billion m3 (oil equivalent) by end of 2012




Until 2020: Expect to increase reserves by 40-50 million m3 (oil equivalent) annually including:

- Oversea: 10-15 million m3 / year




2006 - 2012: Production




2013 - 2020: Forecast



E&P: Vietnam Sedimentary Basins




Total production reached 94 billion m3 up to 9/2013

Gas Pipeline Systems Capacity:

- Cuu Long Basin gas pipeline system: 2 billion m3 of gas/year
- Nam Con Son gas pipeline system: 7 billion m3 of gas/year
- Ca Mau PM3 gas pipeline system: 2 billion m3 of gas/ year
- Phu My Nhon Trach gas pipeline system: 2 billion m3 of gas/year
- Phu My My Xuan Go Dau low-pressure gas pipeline system: 1 billion m3 of gas/year




Gasoline Production (Million ton)

 The Condensate Processing Plant: capacity of 130,000 tons of condensate a year


Urea Production (Thousand ton)



Petrochemical and Bio-fuel:

- Phu My Fertilizer Plant: capacity of 800,000 tons of urea
- Ca Mau Fertilizer Plant: capacity of 800,000 tons of urea
- Dung Quat Polypropylene: capacity of 150,000 tons of polypropylene products a year.
- Dinh Vu Polyester Fiber Plant: capacity of 170,000 tons of fiber a year
- Quang Ngai Bio-fuel Plant capacity of 80,000 tons of ethanol a year



Power Generation - Overview

- 5 major completed plants ~ 2,880 MW
- 12% national grid, target 20-25% by 2015




~ 12.4 billion kWh supplied in first 9 months of 2013
